Minor Waiver and Temporary Guardianship Info

CAPEWAY ROVERS MINOR WAIVER POLICY

Parents of minors take note! We need to have on file a **notarized Minor Waiver signed by both parents** for the insurance company in order for the minor to participate in events at Capeway Rovers MC. All minors riding must fill out a minor waiver. One parent must remain present all day, each day the minor is there. In the case that the minor child only has **one sole legal parent/guardian, LEGAL PROOF is required** (i.e. court paperwork, sole custody paperwork, adoption paperwork, a death certificate, etc.). A temporary guardian may sign for and remain with the minor in place of a parent if and only if the Capeway Guardian Form is completed as instructed below. CAPEWAY ROVERS TEMPORARY GUARDIAN POLICY

Two copies of the Capeway Rovers Guardian Form need to be **completed by the parent and notarized** prior to coming to the track if the parent is not attending the event with the minor. One copy will go to the track, the other will remain with the guardian in case of emergency. This guardian must remain present with the minor all day, each day the minor is there. This form allows the parent to appoint a guardian who can make medical decisions and sign forms if necessary for the minor child. QXNE MINOR WAIVER POLICY

All QXNE Members under the age of 18 must have our Minor Waiver **signed by the minor child, EACH LEGAL PARENT/GUARDIAN**, and the Minor Waivers **must be notarized**. This is required by our insurance in order to receive your membership and participate in QXNE races. We will have a notary on site at each track.

Parents/legal guardians that will not be present with their child to sign the Minor Waiver when picking up the child's membership card will have to **complete, sign, and have the Minor Waiver notarized beforehand**, and the minor must bring the completed/signed/notarized waiver to the track with them. The minor child's **certified birth certificate** must also be presented, so QXNE officials can verify it and make a copy to keep on file with the Minor Waiver. **Premade photocopies** presented to QXNE officials **will not be accepted**.

In the case that the minor child only has **one sole legal parent/guardian, LEGAL PROOF is required** (i.e. court paperwork, sole custody paperwork, adoption paperwork, a death certificate, etc.).

This Waiver is two pages! It must be printed double sided, in color, on white paper, signed by the minor child and legal parent/guardian, and be notarized (can be done at the track if both parents are present). Please use a separate waiver form for each parent/guardian.

QXNE TEMPORARY GUARDIAN POLICY

The QXNE PARENTAL PERMISSION FOR GUARDIANSHIP OF MINOR form is for **MINOR MEMBERS** if a parent/legal guardian will not be attending the event.

The QXNE PARENTAL PERMISSION FOR GUARDIANSHIP OF MINOR form needs to be **completed by both parents and notarized** prior to coming to the track if a **parent is not attending the event with the minor**. This form allows the parent to appoint a guardian who can make medical decisions if necessary for the minor child, and allows the minor child to register as a QXNE Member and participate in member activities.
